30-60 DAYS PRIOR TO THE TOURNAMENT

Confirm format (i.e. shotgun start, scramble, tee times, etc.)
Confirm the number of power carts required for a successful event
Confirm contests (i.e. Closest to the Pin (KP), Longest Drive (LD), Holes in One, Longest Putt, etc.)
Confirm scoring & prizes
Confirm food & beverage details (i.e. Lunch, boxed lunch & dinner menu selection, bar requirements, host or cash bar, beverage cart on course, etc.)
Banquet setup (number of guests, audio visual equipment, prize tables, etc.)

Confirm registration set up (location of tables & chairs required)

15-30 DAYS PRIOR TO THE TOURNAMENT

Confirm on-course details & requirements (signage, ice, meals, tables, chairs, tents or umbrellas, etc.)

Send event details to tournament participants

Confirm menu selections & review alcohol policy

Directions to course; finalize rental equipment (golf clubs, carts, etc.)

Dress code (including spike policy)

14 DAYS PRIOR TO THE TOURNAMENT

Confirm final numbers (no reductions will be refunded after this point). Final balance of estimated cost is due.

7 DAYS PRIOR TO THE TOURNAMENT

Confirm on-site contact person & event timeline Confirm any additional dinner guests attending (*dinner only*) Provide group pairings (*draw sheet*)

2 DAYS PRIOR TO THE TOURNAMENT

Deliver all signage & any other on-course material

TOURNAMENT DAY

CLUB RULES

GOLF COURSE RULES AND ETIQUETTE

Dress Code: Torn Jeans, short shorts, and tank tops are not considered acceptable golf attire. Metal spiked shoes are not permitted.

If you have not reached the green by double par, you must pick up your ball and move it to the next tee. Please remember that all equipment rentals from Tsawwassen Springs require a major credit card for security.

Last but not least, have fun!

RULES FOR SCRAMBLE FORMAT

Four players tee off, pick the best ball of the four and play the ball from that spot.

Four players hit again, pick the best ball and continue the procedure until the ball is holed out.

Through the green: Place a tee in the ground within 12" on the balls position. The ball may be lifted and cleaned. All players now play their shots within a 12" radius of the marker tee.

On the Green: Mark your preferred shot with a ball marker. All puts are now taken from this marker, not closer to the hole.

You must use each player's tee shot at least 3 times.

R.C.G.A and Local rules apply. The host professional will decide any disputes. His decisions are final.

If the ball lands in the sand trap, the trap may be raked between shots.

Ties: All ties will be broken by retrogression. All ties will be broken starting with the 18th hole.

Please obey the orders of the Golf Course "Players Assistant".

Please indicate which hole each players tee shot was used.

Any player who must join their team late only has to record 2 tee shots.

The Foursome team captain is responsible for turning in the score card to the Tournament Coordinator of Tsawwassen Springs.



GOLF TERMS & CONDITIONS

FOOD & BEVERAGE

All food and beverage served in Tsawwassen Springs must be provided by Tsawwassen Springs. The exception of cakes or special occasion cakes. Cake plating fee is \$2.25/ per person.

One menu is required for all guests unless otherwise agreed. Limited dietary substitutes can be made available upon prior request. Menu selections must be submitted to the Catering Office 14 days prior to your function.

All prices are subject to change without notice.

In accordance with BC liquor Laws, all alcoholic beverages consumed in the licenses areas must be purchased by Tsawwassen Springs through the BC Liquor Distribution Branch. Host/ Cash Bar must be closed at 12:00 am and Liquor is not permitted after 12:30am. Any alcoholic beverages not purchased on site will be confiscated.

If any guest in your group has allergies, you shall inform us of the names of such persons and the nature of their allergies in order that we may take the necessary precautions when preparing their food. Should this information not be provided, you shall indemnify and hold us forever harmless from and against any and all liability for any personal injury that does occur.

DEPOSIT & PAYMENT

A non- refundable deposit of \$2000.00 is required to confirm all golf bookings.

A second deposit for 50% of the total value of the event is due 14 days prior to the scheduled event date.

Any outstanding balance is required to be paid within 7 days upon conclusion of the event.

Payment may be made by bank draft, certified cheque or credit card.

We also will require a credit card for our file as a guarantee.

We do accept applications for credit with corporate bookings which can be arranged through our credit department, a minimum for three weeks are required for processing the credit application. Tsawwassen Springs reserves the right to require full pre-payment should the credit application not be approved.

GUARANTEE

A final guarantee is due by 12 noon 14 days prior to your event. If the guaranteed number has not been received, the billing will be prepared for the number of persons for which the function was originally booked, or the number in attendance, whichever is greater.

CANCELLATIONS

A cancellation notice is required 14 days prior to your event. If a cancellation is provided 7- 13 days prior to the function, you will be charged a cancellation fee of 50% of the estimated total costs. If a cancellation notice is provided within seven days of the function, you will be charged a cancellation fee of 100% of the guaranteed total costs.

INSURANCE & INDEMNIFICATION

Tsawwassen Springs will carry and maintain liability and insurance in amounts sufficient to provide coverage against any claims arising from any activities out of/ or resulting from parties respective obligations pursuant to this contract. Complete indemnification policy is available upon request.

GOLF TERMS AND CONDITIONS

HOST BAR

The host pays for all consumed beverages. Applicable taxes and service change are not included in host bar prices. Bartender labour is \$150 per bartender.

Bartender labour is complimentary if consumption exceeds \$400.

CASH BAR

Guests are responsible for paying for their own beverages. Cash bar prices are inclusive of taxes.

Bartender labour is \$150 per bartender.

Bartender labour is complimentary if consumption exceeds \$400.

PARKING

Parking is complimentary for all guests. Tsawwassen Springs is not responsible for damaged or lost items while cars are parking in an underground facility or surface locations.

SECURITY

Tsawwassen Springs is not responsible for articles left unattended in Banquet Rooms or the Golf Course, and will not assume responsibility for any loss or damage to items and material brought into Tsawwassen Springs.

Tsawwassen Springs, at its discretion, may require security for events at the cost to the client. Any event for persons under the age of 19 will require 1 security for every 50 minors. Only security Services approved by Tsawwassen Springs may be utilized. Security Staff will be arranged by Tsawwassen Springs and will be charged at a minimum of \$50 per hour.

SIGNS AND BANNERS

Signs are not permitted on the exterior of the building or lobby areas without the approval of the Event Sales Manager.

Printed signs for function rooms must be free standing or placed on an easel.

Nothing shall be posted, nailed, screwed or otherwise attached to walls, floors, or other parts of the building or chandeliers, or furniture.

MISCELLANEOUS

Tsawwassen Springs Management reserves the right to inspect and control all private functions.

Tsawwassen Springs will not assume the responsibility for the damage to or loss of any merchandise or articles left in the event facility prior to, during, or following an event.

The guest agrees to be responsible for the conduct of his/her guests and for any damages done to the premises during their event or for any damages done by an independent contractor hired by the guest.

Use of nails, staples, or tacks on any surface other than a corkboard is strictly forbidden.

Tsawwassen Springs reserves the right to provide alternate conference/ banquet room(s) suited to the groups requirements.

Tsawwassen Springs is pleased to accept deliveries and assist in the handling of materials for your event. Due to the limited storage on the property we are unable to accept shipments any earlier than one day prior to your event. Please arrange for the pickup of all items immediately after your function.

GOLF TERMS AND CONDITIONS

SERVICE CHARGES & TAXES

All food and hosted beverages are subject to 18% service charge.

All room rentals, food and beverage service and audio visual requirements are subject to applicable taxes.

Government taxes are applicable as follows:

Special setups and moving of chairs, tables and other equipment during the course of the event may result in applicable labour fees.

SOCAN AND RE:SOUND FEES

A SOCAN License, (fees on behalf of the Society of Composers, Authors and Music Publishers of Canada) and RE:SOUND Fee (fees for the fair compensations for artists and their record companies for their performance rights) will apply for any use of published music during an event. Fee will vary depending on room size and whether performed with or without dancing as follows:
